3 Amendment of State Environmental Planning Policy No 55— Remediation of Land

Clause 19A

Insert after clause 19:

Application of SEPP to certain development at Barangaroo subject to Part 3A approvals

- This clause applies to development that is the subject of the following project approvals under Part 3A of the Act:
 - project application number 10 0023, approved by the Minister for Planning on 2 November 2010,
 - project application number 10 0047, approved by (b) the Minister for Planning on 8 November 2010.
- (2) To avoid doubt, the following provisions of this Policy do not apply to the carrying out of development to which this clause applies:
 - (a) clauses 8 (4) and 17,
 - any other provision of this Policy that prohibits or restricts the carrying out of that development.
