- (a) to prescribe offences under the *Charitable Fundraising Act 1991* and the *Charitable Fundraising Regulation 2021* that may be dealt with by penalty notice and the penalty amounts payable, and
- (b) to update the name of an exempt religious organisation.

1 Name of Regulation

This Regulation is the Charitable Fundraising Amendment Regulation 2022.

2 Commencement

This Regulation commences on the day on which it is published on the NSW legislation website.

Schedule 2 Penalty notice offences

1 Application of Schedule

- (1) For the Act, section 25ZA—
 - (a) each offence created by a provision specified in this Schedule is an offence for which a penalty notice may be issued, and
 - (b) the amount payable for the penalty notice is the amount specified opposite the provision.
- (2) If the provision is qualified by words that restrict its operation to limited kinds of offences or to offences committed in limited circumstances, the penalty notice may be issued only for—
 - (a) that limited kind of offence, or
 - (b) an offence committed in those limited circumstances.
